Annual Notice of Availability of Consumer Information

Notice of Privacy of Student Records – Family Education Rights and Privacy Act (FERPA): Students have the right to review their education records, to request amendment of records, to consent to disclosures of personally identifiable information, and to file complaints with the Department of Education. Procedures for reviewing records and the institution's policy regarding disclosures of information are located on the school's web site.

Copyright Infringement Policies and Sanctions (including computer use and file sharing): Unauthorized distribution of copyrighted material, including unauthorized peer-to-peer file sharing, may subject students to civil and criminal liabilities. Additional information regarding penalties associated with unauthorized distribution of copyrighted materials is located on the school's web site.
