Sofia University seeks to appoint a Program Chair for the master's programs in Business Administration (MBA) and Computer Science (MSCS). Reporting to the Provost and Chief Academic Officer, the Chair is responsible for academic integrity, operational efficiency and enrollment management for the two programs, both of which have plans for university investment and growth. This full-time position provides leadership to faculty in the design, delivery and assessment of curricula for the two degree programs, represents the programs to the senior administration and external publics, and maintains regular communication with students, applicants and other stakeholders. As part of the Academic team, the Chair sits on the Provost's Council and additional governance committees, endeavors to adhere to policies and practices developed by those bodies, and represents the field and degree programs in business administration and computer science in University planning and policy development. Emphasis is placed on supporting students from recruitment to their degree completion and transition to alum status.

The Chair is located at our Palo Alto, CA campus (though consideration will be given to candidates near the Costa Mesa, CA branch campus).

Essentials Functions and Responsibilities

Administrative, curricular and instructional responsibilities include but not limited to:

- Initiate the planning, articulation, implementation and monitoring of goals and objectives for the two programs, including establishment and attainment of learning outcomes and enrollment targets
- Coordinate the hiring and course assignment of Core and Adjunct faculty, including recruitment and selection, development of program-specific orientation and onboarding, and assistance of Human Resources
- Ensure quality of instruction and a positive student experience across the programs; review quarterly faculty evaluations and conduct classroom observations
- Schedule program classes to meet student needs, fulfillment of the curriculum, budgetary resources, and processes established by the Registrar
- Coordinate the development and updating of syllabi, online course masters, proposals to amend programs
- Lead the assessment of student-learning outcomes and program reviews as scheduled by the Provost
- Participate in the generation of documents suitable to internal and external review, including respectively for Marketing and Admissions and accreditation by WSCUC and other agencies
- Provide consistent monitoring and guidance to faculty in their accomplishment of instructional, service and other assignments
- Advise students on variety of academic and administrative matters and career opportunities
- Identify qualified faculty to serve on University committees
- Teach a combination of face-to-face and online courses in appropriate discipline
- Additional duties as assigned

Minimum Qualifications

- Doctoral degree in Business Administration or Computer Science, or related discipline
- Experience with stages of the enrollment management process, including student recruitment, advising/mentoring, retention and graduation
- Prior teaching and administrative experience
- Familiarity with online education

Preferred Qualifications

- Industry, scholarly and/or teaching experience at the intersection of business, management, information technology, computer science
- Experience with Canvas LMS and implementation of “best practices” in online and hybrid education
- Strong organizational skills along with an understanding of the rigors and standards of graduate education
- Previous work as (Assistant) Department or Program Chair
- Demonstrated engagement with learning outcomes assessment planning and implementation
- Willingness to learn about Sofia’s transpersonal and transformative pedagogy is desirable, as is a commitment to develop “whole person” values in program delivery
