Professional Licensure Disclosure Master of Arts in Counseling Psychology

U.S. Department of Education Regulations 34 CFR 668.43 (a) (5) (v) and 34 CFR 668.43 (c) require disclosures by institutions regarding educational requirements for programs leading to professional licensure or certification, which applies to both online and on-ground programs.
